Question	Response
Multiple rounds of feedback are anticipated in the RFP. Could GPSDD please confirm how many groups of stakeholders will provide comments? Will the GPSDD contact point review and consolidate comments at each round?	The primary stakeholder group providing comments will be the Evaluation Committee, however it is anticipated that members of the Board, Technical Advisory Group, and Secretariat may also provide comments. Yes, the GPSDD point of contact will consolidate comments at each round before sending to the evaluation team.
The selection and evaluation criteria mentions "subcontracting ability". Can details of the company's management procedures and capabilities be provided in an annex, or do these need to be included in the narrative proposal (i.e. within the 15 page limit)?	A brief narrative of subcontracting ability should be included in the narrative proposal. Additional detail may be provided in the annex.
What databases are available to the evaluator for development of samples for stakeholder engagement?	The selected offeror will have access to the GPSDD partners database, as well as documents detailing GPSDD activity with non-partner stakeholders, and the list of all governance teams' (Board, TAG, Funders Group) members. It is expected that the offeror will conduct some key informant interviews to determine holistic stakeholder samples beyond database information.
Can GPSDD provide details (date and location) of forthcoming meetings for GPSDD task teams and working groups, as well as the annual meeting for the partnership and Board, Technical Advisory Group, and Funders Group meetings?	Task teams and working groups have meetings on an on- going basis. The annual GPSDD-wide meeting is anticipated to occur every 2 years - the first one occurred in March of 2017. The governance team meetings are anticipated to occur twice a year. Locations and dates for the second half of 2018 are still in discussion.
The clarification question deadline of April 30 th allows limited time for potential bidders to consider the methodology prior to submission of questions. Could a second round of questions be added?	We do not anticipate a second round of questions. We encourage offerors to explain assumptions in the proposals as necessary.
Could you please provide the logframe? Could you please confirm what monitoring data would be available (including what indicators would be provided and the periodicity of these)?	The GPSDD logframe can be found at: https://devtracker.dfid.gov.uk/projects/GB-GOV-1- 300403/documents. Some adjustments have been made and the updated version will be provided to the selected offeror. The logframe explains the frequency of data collection. The first full set of data available is for 2017.
What data does GPSDD collect for each of its working groups, and would this be available to the evaluation?	No specific data of the working groups is routinely collected. Any available and relevant documents will be made available to the selected offeror.
What data is held on internal processes (e.g. regarding costs, staff time, etc.)?	Value for money indicators around internal processes, including costs and staff time are tracked on a bi-annual basis and will be made available to the selected offeror.
