1.1	Principle One - All populations must be included in the data.	4	 The establishment of the Differential and Intersectional Approach Group (GEDI by its acronym in Spanish) on March of 2019 intended to include the IDC principles in DANE's strategic vision. The results of the most recent population and housing Census will be published on late July. These results had an expert review, including several international agencies. Other paramount statistics like GDP, multidimensional poverty, CPI, among others, have had methodological updates and reviews, in order to keep the principle one. The action plan includes the review of the information of census. 	
1.2	Principle Two - All data should, wherever possible, be disaggregated in order to accurately describe all populations.	2	Despite disability disaggregation has not been applied to all data produced by DANE, several data disaggregation have been analysed and some of them could be produced with the available information in DANE.	

			On one hand, the SDGs Group in DANE has made a diagnostic to evaluate the data disaggregation in the national indicators that DANE reports in a country level. For instance, data disaggregation to a subnational level has been proposed for some SDGs indicators, in particular, for indicator 8.6.1. Proportion of youth (aged 15–24 years) not in education, employment or training. On the other hand, the Normalization, Standardization, Planning, Regulation Direction (DIRPEN, as its acronym in Spanish) has identified the required data disaggregation to fill-in information gaps in the National Statistical System (NSS). Our action plan remarks on the need to create awareness of this kind of disaggregation as well as our National Statistical Plan. On the same line, GEDI has defined four main approaches –gender, age-life cycle, ethnicity and disability - to leverage the availability of disaggregated data in appropriate conceptual terms.
1.3	Principle Three - Data should be drawn from all available sources.	4	Studies conducted to identify the possible sources of information for the gender observatory and any activities related to identify sources of information in the NSS. In this topic, DANE has survey sources to address main issues on gender economics such as the time use on non-remunerated activities and care economy, and the exploration of administrative records such as Integrated Social Security Contribution Register (PILA by its acronym in Spanish) to calculate gender labour gaps. Last year DANE produced with the support of Statistics Korea, the Protocol for statistics production based on the administrative records, a protocol based on GSBPM standard that order the actions to produce official statistics using administrative records. The DIRPEN has also been working in guidelines to use Big Data sources in DANE, either as a complementary source or as a primary one. Other internal directions in DANE have research in new sources of information e.g., the Geo-Statistics Direction (DIG, for its acronym in Spanish) has been working on usage of satellite images to calculate some SDGs indicators

			(indicators 9.1.1, 11.7.1. has been already calculated and some other are in a preliminary research stage to be calculated).
