1.1	What progress have you made on your Inclusive data priorities/ IDC Action Plan priorities in the past year?	Include examples to accompany any highlights or achievements.	We commit to leaving no one behind by advocating for disability data: o We have continued to advocate for the inclusion of disability data in the global SDG indicator framework to ensure persons with disabilities are counted, measured, and not left behind again in sustainable development; o We supported OPD partners to present in a side event during the Global Disability Summit;	

o We supported OPD partners to present in data values events during UNGA;
o We supported and co-presented on partnerships in the annual Washington Group meeting;
o We supported and co-presented on disability data to different UNFPA Asia Pacific focal points;
o We continued to partner with UNFPA Asia Pacific to carry out disability data work in the AP region, which includes finalizing a training on disability data advocacy for OPDs;
o We convened a meeting of inclusive data stakeholders (including IDC), including OPDs in Nairobi in June. The objective was to bring different stakeholders together to learn from one another about inclusive data in Kenya. A report was written and we're finalizing short videos (with International Sign and captions) that will be launched at upcoming global events, e.g., the World Data Forum 2023;
o We supported an OPD partner and co-presented in a webinar on a global perspective of disability data to NHRIs; o We supported an OPD partners and presented at the IAEG-SDGs meeting and citizen data meeting in Bangkok (forthcoming); and o Continue to work with one of our partners, the World Federation of the Deaf, to strengthen data on deaf persons and to include national sign languages into minority languages and related data collection efforts. We align with the principle of the importance of community and citizen driven data, particularly in a humanitarian context:

o We organized and supported OPD partners in a side event on data and women with disabilities during the Conference of States

Parties to the CRPD;

o We support the International Civil Society Centre's Leave No One Behind (LNOB) Partnership that focuses on collecting citizen-generated data from the most marginalized groups to measure the SDGs; o We started to collaborate with IOM on data on migrants with disabilities: o We contributed as part of the Stakeholder Group of Persons with Disabilities into a publication. The topic is "Inputs on the importance of inclusive data and the role of organizations of persons with disabilities in data collection in humanitarian settings" and is for the report from Internal Displacement Monitoring Centre on about internally displaced persons with disabilities. It will be launched on December 3: o We will support an OPD partner to present in an event on migration and disability data in a webinar "On the road to Santiago" as a lead-up to the IFMS (in January). We support advocacy initiatives that call for inclusive data that promotes transparency, but also recognise the need for protection and confidentiality: o We are part of UNICEF's Strategic Advisory Group of the Centre of Excellence on Data for Children with Disabilities and co-presented and supported an OPD partner to present in the UNICEF workshop on data on children with disabilities. We recognise the need for strengthening our organisation's data skills and we recognise this is also critical for our partners: o We continue to support persons with disabilities and their representative organizations in data advocacy to gather and understand how to use data for advocacy by: § co-coordinating global advocacy efforts for inclusive data via the SGPwD, § co-managing the open-source disability

data listsery, § continuing to disseminate and share the

			disability data advocacy toolkit for organisations of persons with disabilities and translate into different languages and formats (Arabic – soon, English, French, Spanish, Easy Read, International Sign); § are finalizing the disability data advocacy training for OPDs that will be an open source. o We have continued to work in an innovative partnership to build capacity in and increase the quality of disability data in the Asia-Pacific region with UNFPA, in close collaboration with the Stakeholder Group of Persons with Disabilities, the International Disability Alliance, and national and regional organizations of persons with disabilities, including the Pacific Disability Forum and ASEAN Disability Forum. This includes an interactive, eight-module training for OPDs that was piloted at the end of 2021. We received feedback from OPDs from the pilot trainings and incorporated them into the revisions in 2022. We are finalizing the disability data advocacy training for OPDs that will be an open source.
1.2	What areas of your Inclusive data priorities/ IDC Action Plan have you made the least progress on, in the past year?	Include any challenges or barriers faced.	Working on the appropriate and effective use of disaggregated data to improve gaps in our programmes with respect to groups left furthest behind. We have focused on supporting and advocating for inclusive data outside of our organization, but less so on programs within our organization.
1.3	Have there been any changes to your Inclusive data priorities/ IDC Action Plan objectives in the last year?	(Yes, No) If yes, please give details of any changes	Yes. There has been an increased focus on inclusive data priorities. With the development of the advocacy strategy for CBM Global, data was highlighted as a key crosscutting pillar of our advocacy work. In early 2023, we will set up an internal data working group to ensure that disability data work is integrated throughout the federation. We are waiting for our indicator framework to be finalized before forming this group.

We met with the government of Malta and encouraged them to join the IDC and they met with Kate Richards afterward to discuss this possibility further. I have connected with IDC in Kenya (Karen) in the convening we funded, as well as in NYC during the UNGA as part of the Data Values Campaign (with Kate and Karen). Recently, we had a joint call about the EOI of the disability data portal (with Ticha).

We have disseminated the disability data advocacy toolkit, presented about the disability data advocacy training for OPDs, and shared information about the partnership with UNFPA in various events. In partnership with OPDs, or supporting OPDs, we have presented in various events on inclusive data throughout the year. We have engaged with UN Statistics Division on SDG data advocacy, especially since disability data are significantly left behind in measuring the SDGs.
