# INTRODUCTION



## CBM GLOBAL'S OBJECTIVES

aligned with the IDC

There is a pervasive lack of disability data, making it difficult to create policies and programs inclusive of persons with disabilities, who make up 16 percent of the world population. Moreover, there is little data on persons with disabilities in emergencies—as we saw during the pandemic—and on the experiences of migrants, refugees, and internally displaced persons with disabilities. Where there is available data, it often does not reflect the reality of persons with disabilities, or is not harmonized to support the development of comprehensive, evidence-based policies and programs for persons with disabilities.

CBM Global's objectives align with the Inclusive Data Charter (IDC) principles in the following ways:

- We commit to leaving no one behind; this is reflected in both our vision and mission statement and also in our programmatic strategy and program quality framework.
- We are committed as an organization on the appropriate and effective use of disaggregated data to improve gaps in our programs to ensure no one is left behind.
- We align with the principle of the importance of community and citizen-generated data, particularly in a humanitarian context.
- We support advocacy initiatives that call for inclusive data to promote transparency, but also recognize the need for protection and confidentiality.
- We recognize the need for strengthening our organization's data skills, and we recognize this is also critical for our partners.

# WHY WE JOINED THE IDC?

Achieving good quality data that strengthens progress and identifies where gaps persist is integral to CBM Global's advocacy work. In line with Article 31 of the Convention on the Rights of Persons with Disabilities (CRPD), we believe that data should be disaggregated by disability to measure progress in CRPD and the 2030 Agenda for Sustainable Development implementation. We also support the need for necessary safeguards to be in place to ensure that data collected by governments on the barriers and enablers of persons with disabilities is done with the highest standards that protect dignity and privacy.

Our advocacy towards inclusive disability data, which we have undertaken since the adoption of the 2030 Agenda for Sustainable Development, is done in partnership with organizations of persons with disabilities (OPDs) and other allies. This includes supporting persons with disabilities and their representative organizations in data advocacy to generate data and understand how to use data for effective advocacy.

Through our partnerships with OPDs and other civil society organizations, we support inclusive data work in various areas, including in the 2030 Agenda, in humanitarian and disaster risk reduction settings, and in relation to mental health and psychosocial disabilities. We also support inclusive data capacity building of organizations of persons with disabilities nationally, regionally, and globally, including in national statistical offices, UN entities, and NGOs. Implementing our Inclusive Data Charter action plan from 2024 to 2026 will strengthen the above processes, while being part of the multi-stakeholder partnership, the Inclusive Data Charter.

\*\*This will mean building capacity on: being able to know where to find, evaluate, interpret, and use national and regional data based on a greater familiarity with disability data collection tools and types of data; be able to advocate for data collection and investment in better data; be able to use data to develop evidence in support of advocacy messaging; and begin to apply relevant knowledge and skills on data on persons with disabilities in their local context.

\*\*\*For example, one of the results of the project in Indonesia on OPD Capacity Strengthening: 16 OPDs gain capacity building in monitoring the fulfilment of the rights of persons with disabilities in their regions, as well as periodically disseminating the results of monitoring to local governments in their respective regions.
