The Global Partnership (GPSDD) is seeking a consultant, based in Mali, with considerable knowledge of the agricultural sector, food security and statistical system in Mali to conduct an agricultural and food security data gap assessment and inventory. SDG indicators related to these areas. The contract resulting from this award will be a service contract.

The agreement resulting from this RFP will be provided to the most responsive service provider whose offer will be the most advantageous for GPSDD/UNF in terms of cost, functionality and other factors as specified in this RFP.

## Context :

The global food crisis, exacerbated by the Eastern European crisis, supply chain disruptions, and the ongoing economic repercussions of the COVID-19 pandemic, has led to soaring food prices and an increase in food insecurity. This crisis has deeply affected different regions, particularly in West and East Africa, including Mali. Despite the existence of many sources of data, governments are often unaware of the comprehensive data available to address these pressing issues. Moreover, some countries lack the expertise to effectively process and use this data to make informed decisions. Although there is an abundance of data on the food crisis, access, scaling up,

To address this pressing concern, the Islamic Development Bank (IDB) and United Nations Foundation (UNF), through the Global Partnership (GPSDD), are joining forces. Their collaboration aims to provide IDB member countries, including Mali, with access to timely, comprehensive and inclusive data. This essential data will support the monitoring and achievement of the Sustainable Development Goals (SDGs) and underpin evidence-based decision-making.

## **Objectives of the consultation:**

The main objective of this mission is to gather extensive and reliable data and information on the current situation of food security and agricultural practices in Mali. The expert will assess existing data sources, identify gaps and challenges, and offer recommendations to improve data collection and analysis methodologies in the country. **Specifically,**the Consultant will produce a report on the SDG data ecosystem focused on food security in Mali including (i) the inventory of SDG indicators related to agriculture and food security and in relation to the national program fight against food insecurity; (ii) data availability, missing data and methodologies currently used to produce these indicators (data collection and analysis); and (iii) an analysis of the institutional and organizational frameworks and mechanisms in place.

# Methodology of work

The selected expert will undertake the following tasks:

- Review and compile existing literature, reports and datasets related to food security and agriculture in Mali.
- Conduct interviews and interact with relevant stakeholders, including government officials, local farmers, NGOs, and international organizations active on the ground to document the social, political, legal and other contexts within the agricultural sector and on data issues in the sector.
- Analyze the current data collection and management systems as well as the technical capacity in place for food security and agriculture data, including data sources, methodologies and gaps.
- Identify challenges and limitations in data collection and analysis, such as data quality issues, accessibility and timeliness.
- Assess the capacity of relevant institutions and organizations involved in data collection, analysis and reporting.
- Compare and assess data systems and practices in Mali with international best practices and standards.

• Propose recommendations to improve data collection, analysis and reporting mechanisms in the food security and agriculture sectors.

• Write a comprehensive report summarizing findings, recommendations and an action plan for future data collection and analysis initiatives.

# Deliverables

The expert is expected to provide the following deliverables:

• An introductory report detailing the proposed research methodology, data sources and work plan.

• An interim inventory report summarizing the diagnosis, the first conclusions and the draft of the action plan for the production of missing data

• A final report presenting detailed findings, analysis and recommendations with a clear and summarized action plan to improve the food and agricultural security data landscape in Mali.

• A powerpoint presentation of the final report, summarizing the main conclusions, recommendations and actions to be taken in the short and long term.

The consultant will liaise with the Department of Agricultural and Environmental Statistics (DSAE) within INSTAT Mali, for the resolution of any difficulties encountered in relation to the delivery, while working with GPSDD on contractual issues.

All submissions are due by the date and time listed above. Any proposal received after the time and date required for receipt will be considered late and non-responsive. Late proposals will not be evaluated.

# **Section 1: Selection**

The GPSDD, in collaboration with *the DSAE*, will review the proposals with the aim of selecting the most advantageous offer for the GPSDD, based on the qualifications listed above, as demonstrated in the proposal documents. The GPSDD will consider the ability of the provider to deliver the scope of services and the feasibility of the approach. The GPSDD intends to enter a contract that provides the best value for money, not necessarily the lowest price. The GPSDD can meet one or more applicants before the selection.

# Section 2: Conditions of the call for service proposal

United Nations Foundation (UNF) reserves the right to:

- To decline any or all offers and to discontinue this RFP process without obligation or liability to any applicant or any other party.
- Accept other than the lowest bid.
- Award a contract on the basis of the initial offers received, without discussions or requests for the best final offers.
- Award more than one contract.

This RFP and any response to any written notification are being sent to the Provider solely for the purposes of the Provider's preparation and submission of a proposal. Each service provider must keep the ToR and its content confidential. Any information or materials submitted in response to this call and/or as a proposal (whether successful or not) will become the property of UNF and will not be returned. By submitting a proposal, the offeror must agree that the offer will remain firm for a period of at least 120 days from the closing date of the call. Failure to comply with the specifications and requirements provided in this call may result in disqualification.

# Section 3: Terms of payment

The terms of payment for the service will be based on fixed costs. No advance payment will be granted. Payment is contingent upon receipt of a valid invoice and is contingent upon successful completion of tasks, at UNF's sole discretion. Payment will be made in US dollars by UNF by check or electronic/wire transfer. The final payment terms of the contract will be controlled, not this appeal.

The service provider will be responsible for monitoring and managing any exchange rate fluctuations that may affect payments. UNF shall not be liable for any losses the Provider may incur due to the conversion of US dollar amounts paid to the Consultant into another currency or bank charges.

#### **Profile and qualifications**

The expert should have the following qualifications and experience:

- Advanced degree (Masters or above) in a relevant field, such as agricultural economics, food security. Experience with data science and statistical development in the agricultural sector would be an advantage.
- Extensive experience in conducting research and analysis in food security, agriculture or related disciplines.
- Knowledge of the food and agricultural security context in Mali, including familiarity with relevant policies, programs and data sources.
- Strong analytical and quantitative skills, with experience in data collection, statistical analysis and report writing.
- Excellent communication and interpersonal skills, with the ability to interact with stakeholders at various levels.
- Perfect command of French and basic knowledge of English are a plus, but not mandatory.

#### **Section 4: Proposal Preparation Instructions**

Proposals should be complete and include the information below. Elaborate or unnecessarily bulky proposals are not desired. Proposals must be submitted in French.

• The proposal must also contain a proposal cover letter, no more than 2 pages

- A technical offer which will include: a brief description of the Service Provider's experience and expertise in the field that illustrates the overall qualifications and capabilities to meet the conditions of this call for service proposal. A brief description of the understanding of the ToR, scope of services and proposed methodology for the work.
- A summary and understandable CV: The service provider must provide a summary and detailed CV.
- List of references: The Service Provider must provide a list of three references, including telephone number, email address and a brief description of the work performed on behalf of the reference (person or institution).
- **Experience in performing a similar activity**: The Service Provider must provide a written sample of no more than 5 pages that demonstrates its ability to convey information clearly and convincingly. The sample can be an excerpt from a document he or she has drawn up with references.

## **Cost requirements**

The Service Provider must include his daily rate. All daily rates must be in US dollars.
